NOT RELEVANT. YOU PURCHASED SOLAR LENSES TO PRODUCE HEAT - BTU'S. PLEASE READ THE EQUIPMENT PURCHASE CONTRACT AND GO TO YOUR IRS FORM 3468 AND ITS INSTRUCTIONS. What documents do you have to support a solar energy plant exists? NOT RELEVANT. YOU PURCHASED SOLAR LENSES. Have you ever gotten anyone else involved in purchasing these solar energy systems. If so, give their complete name and address? HOW IN THE WORLD IS THIS RELEVANT TO YOUR SOLAR LENSES PRODUCING HEAT?
