Greg,

Neldon said that he ordered the lenses we had to buy the lenses to show that they were there. All these should have been paid in full by 2013. He owes \$35,201.00.

He ordered the 42 lenses in 2010 - he would of had his refund back and he never paid for them. Same for 2011 & 2012. The contract says the following year they are to be paid in full. He never paid for them, he just sent in little payments.

Neldon said that the Company could go after the estate to insist that the contracts be paid in full. When people sign up they know that these need to be paid the following year, otherwise they should not be buying them. When he was well and healthy he chose not to pay for them. Now it is a different situation.


Neldon said that the Company will not go after the estate for payment, but that there will be no money paid out on the lenses, or referral fee contracts.
