Dear Judge Nuffer and Defense counsel,

We have revised the draft opinion and order Judge Nuffer sent on July 3; both a Track Changes version and a clean version are attached here. We would like to point out a couple of items in particular:

- 1. In new paragraph 79, there is what looks like an Excel object into the Word document. When I tried to accept the change, a code field changed and the object did not display correctly. So I re-made the table in Word with the identical numbers as are in the Excel object. I've left both visible in the attached Track Changes document.
- 2. In addition to adding the facts and citations that the Judge Nuffer provided, I updated other footnotes that anticipated trial testimony but did not yet have trial transcript citations.
- 3. Where I made other changes that were not directly from the draft Judge Nuffer sent or his factual findings, I typically included a comment box explaining the new text.
