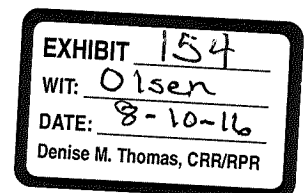

THE FOLLOWING WAS A RECENT EMAIL FROM RAPOWER3 TEAM MEMBER K.K.

Greg,

I am curious as to why the 10% initial payment program is being cancelled. Most people, myself included, would not be able to do the entire amount up front. I am concerned that we are pushing the smaller investor away. If I have to come up with the full 1050 for each unit, it will severely limit the number of units I can purchase in the future. Can you shed some light on this for me?

HERE'S MY ANSWER USING J.T.'s PLAN OF ACTION:

J.T. needs nine lenses (Systems) for his 2013 taxes. He's told his employer to add a few allowances in order to get him \$800 more a month in spendable income. Now, he will use one of two options: First Option: purchase one system in January and pay \$800; purchase one system in February and pay \$800; purchase another system in March and again pay \$800; then in April purchase zero systems but pay \$750. That means after four months J.T. will own another three systems and will have paid his full down payment of \$3,150. Then, he will repeat this process every four months so at the end of the year, J.T. will have all nine systems fully paid for = \$9,450.

Second Option: Simply put the \$800 in a savings account each month and then every four months purchase and fully pay for three systems.
