For tax advice, please seek council from a CPA or other qualified tax professional. After clicking **"BUY NOW"**, put in the sponsor name and follow the directions to apply to become a RaPower3 distributor and purchase your lenses. Becoming a distributor sets you up in your own Independent Solar Business, which is necessary in claiming the valuable depreciation on your taxes. After completing your online application, you are required to pay the down payment on your lenses by check or money order before your purchase and business is finalized. If your down payment is not recieved within 15 days, your Independent Business request will be cancelled.

This is not a purchase of solar panels (photovoltaic) for a residence, but rather a purchase of custom solar thermal lenses that will produce heat that could be used for a variety of industrial and commercial purposes.

70% financing is provided directly from the company. No credit check will be performed. Every purchase instantly qualifies and is automatically enrolled in the 70% financing program with a valid Tax Identificaiton Number from the purchaser. The purchaser may opt out of the company's 70% financing; in such case, the full price of the lens(es) is due at the time of purchase. Payments and interest on the balance owed are deferred until 5 years after the lens(es) begin generating rental income. At the time of purchase, the owner of the lens(es) will enter into an Operating and Maintenance Agreement with LTB, LLC, which includes an annual rental fee of \$150 per lens for the use of the lens(es). Payments to the company on the balance owed by the owner of the lens(es) will be paid directly by the operations and maintenance company, LTB, LLC, subtracted from the rental fee payment as per the Operations and Maintenance Agreement. The purchaser retains all tax credits and other tax incentives for the total purchase price of the lens(es). Please consult with a qualified tax advisor or CPA on how this may apply to you.
