RECEIVER'S FIFTH SPECIAL REPORT ON STATUS OF LITIGATION

R. Wayne Klein, the Court-Appointed Receiver (the "Receiver") of RaPower-3, LLC ("RaPower"), its subsidiaries and affiliates ("Receivership Entities"), and the assets of Neldon Johnson and R. Gregory Shepard, hereby submits this Fifth Special Report on Status of Litigation ("Report"), as of February 25, 2022.

I. OVERVIEW

The Receivership Estate was created on October 31, 2018 with entry of the Court's *Receivership Order* ("Order"). Thirteen affiliated entities were added on May 3, 2019. ²

Subsequent to the Court granting the Receiver's motion to commence legal proceedings,³ the Receiver has filed over a hundred lawsuits against family members, insiders, law firms, credit card issuers, commission recipients, and others. In addition, the Receiver has made demand on others for returns of amounts improperly paid out by Receivership Entities and has settled approximately 30 of these cases without the necessity of initiating litigation.

This Report summarizes the progress to date of the litigation and settlements. The most significant changes since the prior Litigation Status Report are: a) one additional settlement was approved, b) additional settlement payments have been received by the Receivership Estate, c) another district court ruling has been affirmed on appeal, and d) the 13 pending, unresolved cases have been reduced by one.

II. <u>SETTLEMENTS</u>

A. <u>Approved Settlements</u>. The Receiver has filed 13 motions for approval of settlement agreements, all of which have been approved. The statuses of these settlements are:

- B. <u>Delinquent Settlements</u>. The defendants who are delinquent in their settlement agreement obligations are:
 - a. <u>Abdullah, Fareed</u>. He has paid \$991.50 of the \$5,991.50 owed pursuant to a settlement reached before any lawsuit was filed.
 - b. <u>Luke, Shane</u>. Case No. 2:19-cv-00688-DN-PK. Luke has resumed making payments. He has paid \$14,500 toward the \$16,500 he agreed to pay, making his payments 88% complete.
 - c. <u>Bowers, Steven.</u> Case No. 2:19-cv-00530-DN-PK. Bowers has failed to make any payment toward the \$19,800 he agreed to pay. The Receiver will initiate an action against Bowers for breach of the settlement agreement.
 - d. Searcy, Richard. Searcy made his initial down payment in August 2021 but delayed making his required monthly payments. He began making monthly payments in December 2021 but has not yet made up the deficit. He has requested a lower settlement amount based on financial hardship. The Receiver requested documentation from Searcy about certain aspects of his hardship claims. Searcy has not yet provided those documents. Searcy has paid 11% of the total settlement amount.

VI. <u>DISMISSED LITIGATION</u>

On an ongoing basis, as settlement agreements are approved and a pattern of payments is established, the Receiver dismisses the lawsuits underlying those settlements. As noted above, the Receiver intends to dismiss the action pending against Ed Kinsey. The Receiver previously dismissed lawsuits he filed against Korry Ardell and Ryan Davies, without pursuing further litigation or settlements.
