I just want to drop a quick note to you to let you know that I too used Turbotax to prepare my tax returns. Thanks to the info you shared with us I did not have any problems filing my tax returns. I received word yesterday that my federal return had been accepted and in a few days I'm expecting to get my refund of over \$4K; also, I had over \$3500 carryover. I plan to amend my 2005 tax return and get that \$3500+ back as well. Again, thanks for all the information you shared with us--it made my job much easier. T.B.

Finished my return for \$7,210 federal and \$560 state. WOW!! Thanks to Greg for the additional help, I used TurboTax check system about 20 times to be sure. Waiting on acceptance of the returns. Thanks Guys!! Bob D.

TO ALL: Bill D, from Tennessee reports the following success: "I bought ten systems last November and my CPA just informed me that I'm getting back over \$14,000 from my federal returns."

Jesse P., Principal from a mid-size high school in the Northwest, just got an IRS return of \$17,000. That's \$8,000 more than he got last year. He is very excited and is telling all his friends. Looks like we'll have a bunch of new members pretty soon.

An administrator here in the Portland was able to lower his tax rate from 25% to 17% as well as generate a \$19,000 refund. Also, Mike (teacher/coach) and his wife Jen (Administrator) will generate a return of near \$17,000 for this year. Both these cases are significant because all three work in school districts that have cut their contracts 10% for this year and an even greater cut is in store for next year, so the RaPower3 Program is bridging the gap.

Just a note regarding my tax return. I purchased 6 systems in October, 2010. Before applying my Rapower3 tax credits and depreciation. I owed \$7887. After applying Rapower3 to the equation, I am getting back \$1808 to be delivered around March 11th. That's 1.5 more than what I paid for my systems. Thanks Greg and all at Rapower3. I will be purchasing more systems soon. Lindy W.

Andrea purchased just two systems for \$2,100 last December and had \$3,500 wired into her account from the IRS and state by March 11th.

JF purchased 14 systems at a cost of \$14,700. He paid \$16,784 in federal taxes and will get back all of that back. Plus, he will amend his 2005 taxes and get back another \$9,500+. So his \$14,700 turned into over \$26,000 in just a few months. Not bad

Dear Greg,
