Pacific Stock Transfer (PST) is in receipt of your subpoena of records in the above-named civil matter. Additionally, PST is in receipt of a Receivership Order for the same matter. It has been made apparent that your client, Wayne Klein, has been appointed Receiver for International Automated Systems. PST has reviewed the Order and, at the advice of counsel, provides the following information:

Request #1: PST acquired International Automated Systems Inc., (IAUS) as part of an asset agreement with OTC Stock Transfer on February 13, 2017. Limited records and supporting documentation is available. As of the same date, OTC Stock Transfer withdrew its transfer agency from registration and ceased operations.

Request #2: OTC Stock Transfer was the prior transfer agent. No contact information is available.

Request #3: PST has not been made aware of the participation of any market makers, broker-dealers or similar entities that may have served as market makers.

Request #4: Company information as of October 31, 2018 has been provided. See document "Company Information 10-31-18.pdf"

Request #5: PST's review of the order does not name family members as defendants to the matter. The release of this confidential information must be authorized by the shareholder or compelled by a court of competent jurisdiction. PST has provided shareholder reports for the following parties:

Request #6: PST is neither a broker nor a financial institution. Trading volume is not recorded in the normal course of business. A transaction journal has been provided for the period beginning November 1, 2015 to present. See file 'IAUS TransJrl.pdf'. The report

Request#7: No named person has initiated registration of securities pursuant to S.E.C. Rule 144.

Request #8: PST cannot advise what information should be included in a report to the court but offers the following information:

As the registered agent and representative, PST will continue its contractual obligation to provide transfer agent services to IAUS. Currently IAUS has an outstanding balance of \$449.00 due immediately. This is a monthly recurring fee. The appointed Receiver should contact our office during normal business hours to update the company contact information and formerly remove the prior officers. PST will transition the administrative responsibility to the appointed receiver at that time. We require board minutes or resolutions to reflect the changes as directed by the court. PST must also inform the Receiver, as per the transfer agent contract, any disputes arising from the recognition of new appointment will be addressed. Legal actions brought against the firm as a result of any administrative inquiries will be treated as a control dispute and all legal fees will be passed on to the client.

Should the Receiver be required to inform the current shareholders of IAUS of management changes, he should contact our offices to discuss general services and shareholder announcements available to IAUS.
